ACADEMIC COUNCIL Minutes of Meeting

Academic Council -Discussions and Resolutions:

- 1. Academic Flexibility offered in the proposed curriculum R 2019 for UG and PG program was briefed by the Principal. Gave an insight about the curriculum structure encompassing the various course categories such as HS, BS, ES, PC, PE, OE, PW, EEC, Mandatory Courses, Industry oriented courses etc., keeping the AICTE model curriculum as the basis.
- Principal elaborated the steps followed in for arriving at the proposed curriculum. Inputs were taken from ABET, AICTE Model Curriculum, Gate syllabus, PEOs and PSOs of the department and other Premier Institutions.
- 3. Principal explained the subjects offered in the first semester including theory and practical under various course categories and its credit distribution.
- 4. Resolved and approved the regulations and Curriculum of R2019 for both UG and PG Programs.
- 5. The members advised on introducing tutorial hours for the analytical subjects including Mathematics courses.
- 6. Resolved to have the following credit distribution in R 2019 Regulation for both UG and PG Programs

Definition of Credit:

l Hr. Lecture (L) per week	1 credit
2 Hr. Tutorial (T) per week	1 credit
2 Hr. Practical (P) per week	1 credit

- 7. Members suggested that the total credits can be maintained upto 162 credits for UG program and it should not go below 160. Hence decided to maintain the credit range from 160-162 to maintain uniformity among all programs.
- 8. Resolved to have 5 modules in the syllabus irrespective of all Theory Courses in all Programs.
- 9. Resolved and approved to have Language Elective in the Second Semester in which students will be offered to study Business English with BEC module and in which BEC Certification is optional. However, a Diagnostic Test with equal weightage in all LSRW (Listening, Speaking, Reading and Writing) skills will be conducted in the end of First Semester to assess the English Proficiency of a student. If a student has attained the minimum prescribed threshold level in all the above skills, he or she can study either German Language or Japanese Language as the Language Elective.
- 10. Members emphasized for one year Student Abroad Program (SAP) and it was resolved to have SAP for a period of 6 to 12 months. Students meeting the requirement as given in the Regulation can do SAP
- 11. Resolved that under the flexibility to register courses, a student from Vth semester, is permitted to add course registration for two electives (PE and / or OE category) and to a maximum of 30 credits. However a student having nil arrears and a CGPA of 7.5 and above is only eligible.
- 12. Members stated that the student can take up any number of on-line courses but only one elective course (PE or OE with 3 credits) can be dropped in relevance to it.

- 13. Resolved that students having overall attendance less than 70% in a semester are not eligible to appear for the Semester End Examination due to shortage of attendance.
- 14. Resolved to conduct supplementary examination after the VIIIth semester in which a student can appear to a maximum of 5 arrears.
- 15. Revaluation and Review Revaluation Scheme was approved by the Academic Council members.
- 16. Resolved to revise the Grade awarding system and follow the norms stipulated by TNSCHE meeting and the revised grading system are as given below.

- 20. Resolved and approved the assessment pattern of project work with the following modifications
 - a. Two reviews for innovative/mini project work instead of three reviews (Marks split up: Review 1-20 marks, Review 2- 20 marks and report evaluation-20 marks, Total 60 marks as internals)
 - b. Remove the role of HOD in evaluation of the project reports in both Phase-II and restrict the report evaluation with Guide and project coordinator.
 - c. The publication of project work phase-II may either be in conference or in related journals.
- 21. Resolved to have following composition for Semester End Examination QP setting and evaluation
 - a. QP setting- Minimum 50% external. (The selection of QP can be done by means of putting lot in a confidential manner to avoid biasing from any means)
 - b. Evaluation-Minimum 50% external faculty members.
- 22. Resolved to conduct examination and evaluation for the existing II, III and IV year students as they are also covered under Autonomous category. However, the regulation, curriculum and syllabi stipulated for the existing batch given by Anna University has to be followed (Internal Marks, QP pattern, Grading etc.,)
- 23. Placement Director briefed on the syllabus offered in Soft Skills and the mode of evaluation framed to assess the students. The assessment Pattern is 40:60 (Internal: External) and it was approved.
- 24. Academic Council insisted to send a letter to the COE, Anna University, Chennai regarding the conduction of examination and evaluation for the existing II, III and IV year students.
- 25. AC advised to get the willingness from the present II, III and IV year students regarding the migration from affiliated stream to Autonomous stream and send letter to all the parents of II, III and IV years about the same.
- 26. AC advised that the arrear examinations for the passed out students should be conducted only by Anna University.
- 27. Resolved to fix the examination fee and other exam related fee norms as per the requirement by the COE.
- 28. Resolved to have separate basket of courses for both PE and OE category offered by the departments.
- 29. Resolved and approved the Minutes of meeting of the SH, CSE & IT, ECE& CCE, EEE, and MECH Board of studies meeting held on 13.07.2019.
- 30. Members suggested to provide soft skills (Conflict Management, Project Management) coaching to the faculty members to improve their competency.
- 31. Resolved to follow the admission procedure stipulated by Anna University for students Admission.
- 32. The meeting concluded with the vote of thanks delivered by Dr Sudha Mohanram, Principal SECE.






